Corporate Department

The department provides legal counsel across various commercial law fields, with a specialist partner leading on each. The firm advises on the legal aspects underpinning domestic and international corporate activity, mergers and acquisitions, capital markets and securities, insolvency, corporate recovery, banking and finance, tenders, IP, start-up companies, environmental law, cleantech and clean energy, insurance, projects and infrastructure, cooperative and agricultural associations, health funds, defense companies and more. It represents corporations, financial institutions, commercial, industrial and service companies, in the public and private sectors alike, banks and insurance companies, ministries, municipalities and local councils and provides legal counsel to some of Israel's largest corporations.

Litigation and Dispute Resolution Department

The department's motto is to have disputes resolved or decided to its clients' satisfaction in a creative, resolute, prompt and effective manner. Its attorneys enjoy extensive knowledge, expertise and experience in managing legal proceedings throughout the court system and in arbitration, as well as in dispute resolution through negotiation, mediation and conciliation. The department handles civil, commercial and administrative lawsuits, including class actions and derivative suits, contractual and commercial claims, legal actions and proceedings related to corporations and securities, investor claims and shareholder disputes, real estate, planning and construction, banking and finance, insolvency, insurance, tenders, communication, technology and Internet, intellectual property, antitrust, environmental protection, libel and protection of privacy, and more. The department also specializes in administrative litigation (e.g. petitions to the Supreme Court of Justice), and in litigation proceedings against the State, local authorities and other authorities.

Real Estate and Finance Department

The department provides end-to-end legal services in the real estate arena, including purchase and sale of land and other real estate, lease transactions; supporting developer and contractor projects, handling urban renewal, redevelopment and TAMA 38 projects; guidance of purchase groups and construction associations; conseling contractors in zoning and licensing proceedings; handling of objections in planning committees, and related administrative petitions; dealing with construction and zoning violations, co-ownership

dissolutions, and more. In terms of finance, the department advises its clients, including banks, insurance companies, corporations, investors and other financial institutions on all legal aspects of banking activity and financial services, legal support in complex financial transactions (including syndication transactions), borrowers' and lenders' financing transactions for complex and large-scale projects, planning and creating relevant collateral/security and advising banks and financial institutions on regulatory issues. A key specialty is the rendering of "true sale" opinions in the sale of financial assets.

Employment Law Department

The department handles all aspects of collective and individual employment law. Its extensive experience in employment law is built on in-depth knowledge, creativity, and a solid understanding of employment relations. Its services include representation of employers in the various employment courts (civil and criminal cases), the provision of ongoing advice to employers, including the implementation of work procedures and methodologies in accordance with employment law, advising on major employer milestones (mergers and acquisitions, privatization, due diligence, extensive layoffs, etc.), representation vis-à-vis the authorities (including the Commissioner for Women's Employment, the Department of Labor Law Enforcement at the Ministry of Economy and Industry, the Ministry of the Interior), drafting of collective bargaining agreements and managing negotiations with labor unions, drafting of legal documents (including employment contracts, termination of employment documents, procedures, employment matters for prospectuses, periodic reports and more), handling of foreign employees issues (including vis-à-vis the Ministry of the Interior), etc. The department also specializes in employee rights in insolvency proceedings and visas for foreign employees, and has extensive experience in representing international companies and collaborating with foreign law firms with regard to the employment of employees overseas.

Outstanding Areas of Expertise

Cooperative societies and agriculture

The firm has a unique and long-standing specialization in the area of agriculture and cooperative associations, including provision of legal services to cooperatives and kibbutzim, plants, regional and central organizations in the agricultural sector, and to national organizations at the managerial, business and administrative level.

Corporate recovery, creditors' arrangements and insolvency

The firm is widely regarded as a leader for its specialization in receivership, liquidation, stay-of-proceedings, management and recovery of distressed companies, restructuring, representation of creditors and debtors, drawing up and implementation of creditors' arrangements, arrangements with bondholders, as well as insolvency-related litigation.
